Before answering the questions that follow, please read this information about CONTACT.

CONTACT's hotline (telephone counseling service) provides free and confidential 24-hour telephone counseling, crisis intervention and information and referral to persons in distress or crisis. The service is available by calling 315-251-0600. Certified volunteers who assist callers with a wide range of problems and issues staff the hotline. CONTACT is a United Way agency.

CONTACT volunteers receive 50 hours of free training (consisting of 30 hours of classroom training and 20 hours of practical experience) over a 10-week period that addresses all the skills necessary to handle any type of caller to the hotline. Volunteers agree to a one-year commitment of 2 four-hour shifts per month (8 hours per month total) at CONTACT's hotline site. Volunteers choose shifts from 7 a.m. to 11 p.m. 7 days a week. Volunteer telephone counselors are caring listeners who provide a safe, nonjudgmental environment in which callers can discuss their problems. A professional staff member is always available to assist volunteers, as necessary.
